GENERAL SALES TERMS PRICE LIST FOR ACCESSORIES AND SERVICES

CERTIFICATES:

Mecavit S.r.l. can provide following documents/certificates, in accordance with UNI EN ISO 10204 standards. These additional documents are **to be requested at the time of order and included in the order itself:**

2.1 – CERTIFICATE OF ORDER CONFORMITY

This certificate states that the goods have been produced, checked and tested in accordance to the drawings and/or with the applicable regulations, agreed during order negotiation.
This certificate is provided without any additional charge, but only on demand.

2.2- CERTIFICATE OF CONTROL

This certificate states the following values, for each production batch, by taking them from the control data sheets filled in during the production process:

- chemical analysis of raw materials;
- dimensional measurements;
- control of the mechanical properties;
- checking of surface treatment and coating application, if foreseen.

The price of each certificate is 50.00 Euros (fifty).

3.1. – TEST CERTIFICATE

This certificate reports the same data as Certificate 2.2, but extrapolating them by means of additional controls carried out on a specific sample of the supplied batch.

The price of each certificate is 150.00 (onehundredandfifty).

- PPAP Level 1, 2, 3, 4, 5 (according to PPAP-AIAG manual) and VDA2 Level 0, 1, 2, 3 (according to VDA manual Vol. 2)** to be required at the time of the inquiry: carried out on each code – **400.00 Euro** (four hundred).

For washers/special treatments, the price will be calculated on the cost applied by the sub-supplier.

- IMDS:** IMDS data entry **100.00 Euro** (one hundred). Included in case of order for PPAP or VDA.
- 100% product sorting:** 100% sorting on single batch, by using either optical systems or eddy currents (all parameters and ppm rate to be indicated in the inquiry).
- Salt spray test:** salt spray test for corrosion resistance - the relative cost will be quoted on request.
- MINIMUM ORDER AMOUNT:**
